INSTRUCTIONS

PRODUCTS WHICH REQUIRE REGISTRATION

In Vermont pesticides are defined as economic poisons and require state registration. Vermont law defines an economic poison as: any substance produced, distributed or used for preventing, destroying or repelling any insects, rodents, nematodes, fungi, weeds, or other forms of plant or animal life or viruses, except viruses on or in living humans or other animals, which the Secretary shall declare to be a pest or any substance produced, distributed or used as a plant regulator, defoliant or desiccant.

Pesticide products are misbranded if they do not display an EPA Registration Number. Pesticide products which are 25(b) federally exempt (minimum risk) are required to be registered in Vermont. For any questions please contact

TO REGISTER A NEW PRODUCT

Submit the completed application, labels and appropriate fees. Please type or print all information and list products in order.

Submit:

- Copies of actual labels in distribution, (not-EPA stamped/specimen) and SDSs should be submitted on a CD, thumb drive or other electronic readable media. Alternatively, labels & SDSs may be submitted *via* ALSTAR
- Labeling is required by the State of Vermont for registration of 25(b) federally exempt products, including a copy or statement of all claims that will be made for this product.
- Include list of each new product name and EPA registration number or UPC Code for 25b products.
- Sign and date form.
