Act 135 of 2022: 6 V.S.A. § 4927—Farm Surface Water Withdrawal Reporting Form

Beginning on January 15, 2023 and annually thereafter, any person who withdrew 10,000 gallons or more of surface water within a 24-hour period in the preceding calendar year or 150,000 gallons or more of surface water over any 30-day period in the preceding calendar year for farming shall file a report with the Secretary of Agriculture, Food and Markets.
